Welcome

Welcome to the HEREIAM Beta Program. As one of our selected crowd testers, you receive lifetime free access to the HEREIAM platform under the following conditions. Please download and keep a copy of this agreement for your records.

Your Commitment

- Use the app at least once every 24 hours.
- Maximum 3 sessions per day (day defined as 00:01am to 11:59pm same date).
- Inactive for 24 consecutive hours: account automatically suspended.
- Reinstatement on request: hereiam.info@proton.me or via Instagram / TikTok @hereiam_app

What We Ask

Voluntary — but valued in assessing continuation of your free lifetime status:

- Report bugs or issues using the in-app bug report button.
- Share honest feedback on your experience.
- Respect other users on the platform.

What You Get

- Free lifetime access to all platform features.
- Zero commission on all transactions, for life. The platform fee appears in the bill but is automatically deducted — you will never be charged.
- Direct line to the product team via the in-app bug report button.

Important Terms

- This agreement is personal and non-transferable.
- HEREIAM reserves the right to revoke tester status for misuse or inactivity.
- Your data is protected and will never be shared with third parties.
- HEREIAM reserves the right to modify these terms with reasonable notice.

Transaction Limits (Beta Period — max 1 month)

During the beta testing period, sessions are limited to a minimum of 1 and a maximum of 3 per day. Transactions during this period use virtual currency — no real money is processed by HEREIAM.

Users are encouraged to use the app intelligently, test it with contacts, report bugs and malfunctions, and integrate it into their daily routine as much as possible. Any real exchange of money between users during this period is not HEREIAM's business — the primary goal is testing.

At the end of the beta period, all transaction limits are removed. Lifetime members use the platform with no commission charged by HEREIAM — ever. You pay for the service you receive or get paid for the service you provide. No markup. No fees. For life.

By submitting the beta registration form and tapping 'I AGREE' on first app launch, you confirm that you have read, understood, and accepted all terms of this agreement.

Confidentiality and Intellectual Property

1. Definition of Confidential Information

“Confidential Information” means all information, materials and technology disclosed or made available by HEREIAM to the Tester, including, without limitation, the Application, APK file, source code, object code, architecture, designs, business methods, know-how, trade secrets, documentation, and any related technical or commercial information (collectively, the “Confidential Information”), all of which shall remain the exclusive property of HEREIAM. The Tester acknowledges that HEREIAM has filed an application for registration of its trademarks and that no ownership, license or other intellectual property rights are granted under this Agreement, except for the limited, revocable right to use the Application solely for the purposes of the Crowtest Phase.

2. Purpose

The Tester may use the Application solely to evaluate and test it during the Crowtest Phase and to provide feedback to HEREIAM.

3. Obligations of the Tester

- Keep all Confidential Information strictly confidential.
- Not directly or indirectly disclose any Confidential Information to any third party.
- Not copy, reproduce, modify or create derivative works from the Application.
- Not reverse engineer, decompile, disassemble or otherwise attempt to discover or extract the source code, algorithms or internal operation of the Application.
- Not capture, publish or distribute screenshots, photographs, recordings or videos of the Application except where expressly requested in writing by HEREIAM for testing purposes.
- Not use any Confidential Information obtained under this Agreement to develop, market, assist, participate in, or otherwise facilitate any product or service that directly competes with HEREIAM for a period of one (1) year following the termination or expiration of this Agreement.

4. Return or Destruction of Confidential Information

Upon HEREIAM's written request, or immediately upon the conclusion of the Crowtest Phase, the Tester shall promptly return or permanently destroy all copies of the Confidential Information, including any APK files and related materials, and shall confirm such destruction in writing upon request.

5. Survival

The obligations contained in this Clause shall survive the termination or expiration of this Agreement for a period of five (5) years, provided that any obligation relating to trade secrets shall continue for so long as such information remains a trade secret under applicable law.

6. Remedies and Enforcement

The Tester acknowledges that any breach of this Clause may cause irreparable harm to HEREIAM for which monetary damages alone would be an inadequate remedy. Accordingly, HEREIAM shall be entitled to seek injunctive relief, damages, recovery of legal costs, and any other remedy available at law or in equity.

This Agreement shall be governed by and construed in accordance with the laws of the Federal Republic of Nigeria, and the courts of Nigeria shall have exclusive jurisdiction over any dispute arising out of or in connection with this Agreement.
